José María Carabante is a lecturer in Philosophy of Law and Human Rights at the Faculty of Law of the Complutense University of Madrid. D. in Law from the same institution (2009), he began his academic career in 2007 at Villanueva University, where he taught various subjects (Theory of Law, Philosophy of Law, Human Rights, Introduction to Law), in different Degrees and Bachelor's Degrees, until his incorporation to the Complutense University in 2020.

As for his research career, he has been awarded two sexenios (six-year honours). He is the author of the following **monographs**: *Perfiles Jurídico-Políticos* (Thomson-Reuters Aranzadi, 2022, in press), *La suerte de la cultura* (La Huerta Grande, 2021), *Mayo del 68* (Rialp, 2018), *Historia de la Filosofía* (Editorial Casals, 2009), and *Entre la esfera pública y la política discursiva* (2013 Difusión).

He has **coordinated** several **collective works**, together with other authors; particularly relevant has been the one that deals with the configuration of a right to truth in today's information society: Mercedes de Prada and J. M. Carabante, *El derecho a la verdad* (Tirant Lo Blanc, 2021), in which more than 12 professors, prosecutors and judges collaborate. He is also co-editor, together with Jaime Rodríguez-Arana, of the work, *La mediación. Pasado, presente y futuro de una institución jurídica* (Netbiblo., 2010).

His main contribution has been to offer in his works analyses of both anthropological and contemporary ius-philosophical currents, dealing especially with the relationship between the individual, society and technologies, as well as the current conformation of the political community. He has been invited on two occasions by the Universidad Autónoma de México to participate in the World Congresses on Philosophy of Law. He has also been a guest lecturer at the University of Guayaquil (Ecuador).

For more than ten years he has been the secretary of the journal *Anuario Jurídico Villanueva* and is currently an external evaluator of other publications, such as the *Revista Telemática de Filosofía del Derecho* or *Isegoría*. He is a member of the editorial board of *Las torres de Lucca* (Scopus).
