During this visit to Philadelphia, two teams of students representing asylum seekers were supervised throughout the various stages of their application and the US Immigration Courts were observed on various occasions. The aim of this research was partly pedagogical: to provide a basis for the establishment of a legal clinic at the University of Malta and partly theoretical: to understand the way in which asylum narratives are converted into legal discourse in the context of a purely adversarial mode of litigation.
